## NOTIFICATION

No.SOR-IV(S&GAD)15-1/2012. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), and in supersession of Notification No.SOR-III (S&GAD)1-35/93, dated 17.04.2002, the Governor of the Punjab is pleased to direct that notwithstanding anything contained to the contrary in the method of recruitment prescribed in all the service or recruitment rules but subject to paras 2 and 3 of this notification, 15% of the total number of posts shall be reserved for women, where posts are to be filled through recruitment without any reference to gender.

- The reservation of vacancies referred to above shall not apply to the:
  - vacancies reserved for recruitment on the basis of competitive examinations to be conducted by Punjab Public Service Commission;
  - recruitment made by promotion or transfer in accordance with the relevant rules; (b)
  - (c) short term vacancies likely to last for less than six months; and
  - isolated posts in which vacancies occur occasionally. (d)
- In case the vacancies reserved for women cannot be filled on account of non-availability of qualified women applicants, the said vacancies shall be treated as non-reserved and filled on merit.
